Presentation Synopsis – Crane Safety in Construction

The presentation is a brief overview of the 1926 Subpart CC individuals' requirements when using cranes on a construction site. We will cover requirements for Site Supervisors, Assembly/Disassembly Directors, Lift Directors, Crane Operators, Rigger and Signal roles, and Crane Inspection requirements.
